- Carmarthen, South Wales Dormouse surveys along a 4km section of railway line in south Wales as part of
 proposed vegetation clearance works for public safety reasons. Dormouse presence was confirmed, leading to
 the procurement of a development licence from the Welsh Assembly Government. Works were undertaken under
 the supervision of an ecologist and mitigation measures provided in the form of replacement planting and nest
 box installation. The project involved significant dialogue with Countryside Council for Wales and Network Rail to
 ensure that a solution was found which was amicable to all parties concerned (Network Rail/Fountains).
- Species-rich road verge botanical and habitat survey and provision of management advice (National Assembly for Wales).
- The provision of a toolkit and associated guidance on quality in species survey and decision making (Welsh Assembly Government).
